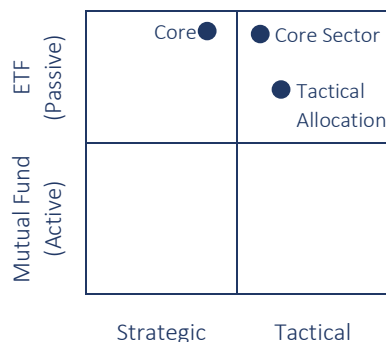

Winthrop Capital Management Exchange Traded and Asset Allocation Model Portfolios:

- Broad Market equity exposure designed to capture the market basis, encompassing over 18,000 global stocks
- Diversified investment grade and high yield bond exposure designed to capture market movements in interest rates over a universe of 7,964 fixed income funds
- Diversified Index ETF's which help to improve tracking error and correlation target benchmarks while reducing turnover and fees
- Risk defined strategies using our Risk Score help to manage portfolio to a specific Model Risk Score which helps to manage Portfolio Risk over time.
- Low cost, with weighted average expense ratios for Core and Core Sector Series ranging from 0.08% to 0.20%, providing an advantage to investors.

Winthrop Capital Management ETF and Tactical Allocation Model portfolios are managed in the context of the current market environment and consider the outlook for expected returns and expected volatility for asset sectors. Our portfolio Models are managed by an experienced investment team using our proprietary risk analytics system called WOMBAT™.

Our ETF and Tactical Allocation Model portfolios are designed to be managed on different custodial platforms.

We believe that investors maximize their chance of successfully achieving their investment goals over their investment horizon when they utilize a diversified asset allocation which includes investable assets designed to achieve their individual investment objectives and risk tolerance. A well-diversified portfolio includes investing in securities that are non-correlated and move in different directions as market prices change. This allows the portfolio to be re-balanced as market prices change across a range global equity, fixed income, and other asset classes such as commodities, at a low cost.

Winthrop Capital Management Approach to Model Portfolio Structure:

To help Financial Advisors and investors address their diverse needs, we offer our ETF and Tactical Allocation Model portfolio strategies in a range of equity/fixed income allocations. All our Model Portfolio strategies provide a range of exposure to domestic and international stocks and bonds.

ETF Model Portfolios: are structured using Exchange Traded Funds that are designed to be low cost and trade efficiently on the specified custodial platform.

Tactical Allocation Model Portfolios: are structured using no-load Mutual Funds and Exchange Traded Funds that are designed to be low cost and trade efficiently on the specified custodial platform. The Tactical Allocation Model portfolios may include an allocation to Alternative Assets which are investment strategies that are intended to further diversify a portfolio beyond stocks and bonds. This helps to further mitigate portfolio risk with the potential for achieving investment horizon returns.

All of the ETFs in our Model portfolios track broad market or market-segmented indexes. Each index is market capitalization weighted. This means that the components of the ETF reflect the structure of the market or the market segment that it tracks. Using ETFs in a model portfolio structure helps to keep costs low relative to the average actively managed investment strategy.
